We are writing to follow-up on a letter sent to you regarding your eligibility to become a member of SAG-AFTRA. Most performers consider receiving their SAG-AFTRA membership card to be a milestone in their professional careers and we are pleased to extend our welcome to you by way of this letter. We hope to hear from you soon.

Please take a moment to visit our website, [SAGAFTRA.org](http://SAGAFTRA.org) to fully explore all the benefits of union membership. For nearly 80 years, SAG-AFTRA has protected performers' rights, wages and working conditions and offered special member seminars, panels and classes to assist members in sharpening their craft.

All new members pay a one-time-only initiation fee, plus semi-annual dues at the time of joining. The national initiation fee rate is currently \$3,000 (initiation fees may be lower in some states). Annual base dues are \$214.32. In addition, work dues are calculated at 1.575 percent of covered earnings up to \$500,000.

Simply contact one of the Membership Departments listed on the reverse side of this letter to determine the initiation fee in your area. Understanding the issues that performers and broadcasters face, the SAG-AFTRA Federal Credit Union ([sagafratfcu.org](http://sagafratfcu.org)), in partnership with SAG-AFTRA, has designed a loan program that eases the financial burden of the initiation fee for those who qualify. Loans are also available through the Actors Federal Credit Union ([actorsfcu.com](http://actorsfcu.com)). You may also contact them directly at (212) 869-8926, or outside NYC (800) 222-8677. Please read the enclosed flyer for details.

As stated in our previous letter, in some states (including New York and California), SAG-AFTRA's collective bargaining agreements require that you become a member or pay SAG-AFTRA certain fees in a manner described in the enclosed document.

Your name has been submitted to SAG-AFTRA by a producer requesting information as to whether you are current in your financial obligations to the union. SAG-AFTRA has cleared you for employment. However, should you not join SAG-AFTRA or pay the appropriate fees by February 7, 2019, SAG-AFTRA may not clear you in the future.

We look forward to welcoming you and adding your voice and professionalism to approximately 160,000 members worldwide.
